Membership Agreement

I, (please print name) _____, am either head of my household or the spouse of the head of my household, who is responsible for payment of the dues for my family's membership.

Note: In the context of this document, all persons included in this membership as indicated on the previous page of this agreement, are henceforth referred to as "members"

Members agree that Sherwood Swim Club (SSC) employees and its Board of Directors (SSCBD) have authority and responsibility to enforce any and all rules governing all aspects of operation for the pool and the safety of it's members and visitors.

While on the premises of SSC property, members agree to abide by, and obey the SSC By-Laws, posted rules, and any verbal directives issued by an SSC employee or member of the SSCBD.

Members acknowledge that the BSSCBD may convene a Membership Review meeting, for the purpose of evaluating the merit of continued membership of any member, when any of the following conditions apply. This list is not all inclusive, but rather a guide in determining the seriousness of any infraction(s):

Willful damage to, or destruction of, SSC equipment or property. Flagrant disregard of SSC posted rules. Failing to follow the spoken directives of SSCBD member or SSC employees Disregard for the safety and well being of others

Note: Time Outs (TMO) will be implemented for less serious infractions. TMO are at the discretion of the person in authority and may be of any length of time not to exceed 1 day.

It is imperative that any member witnessing unsafe acts or practices, take immediate action to cause that activity to cease. This may be accomplished through implicit authority that is hereby granted under the stated conditions and may be accomplished in any of the following manners:

Vocal directives from the observer of such unsafe acts or practices to the persons participating in the action.

Notification to Lifeguard or SSCBD member

Other adult SSC member

Other SSC employee

In all cases, members or their representative, are required to report all such cases to any SSCBD member at the earliest possible opportunity.

This signed membership agreement, will be retained by SSC as a permanent record of my membership.

Family Membership is limited to spouse, live-in children, other live-ins and immediate grandchildren.

I have read and understand the membership agreement and rules. Any guests I bring, I am responsible for them also understanding these rules and I am responsible for my guests.

Pool Rules

1. All members and guests must sign in prior to entering pool enclosure.
 2. Lifeguards and Board members are in complete authority at all times.
 3. All swimmers must take a shower before entering the pool.
 4. Persons with contagious or infectious health condition (cold, flu, ear fungus, skin diseases) are not permitted in the pool.
 5. No running on pool deck.
 6. No glass allowed in pool area.
 7. No smoking allowed in pool area.
 8. No smokeless tobacco allowed in pool area.
 9. No pets allowed in pool or pool area.
 10. No hard balls, bats, frisbees, objects, etc. allowed in pool area.
 11. No sitting or hanging on lane ropes or life line.
 12. No swimming in diving area when diving boards are in use.
 13. No profanity or abusive language will be tolerated.
 14. No spitting or blowing nose in the pool or pool area.
 15. No dunking, splashing, shoving, hitting or rough horseplay allowed.
 16. No diving from the side of pool in shallow end. Diving only allowed in diving well.
 17. No alcoholic beverages or intoxicants allowed on property belonging to Sherwood Swim Club Inc.
 18. No illicit drugs allowed on property belonging to Sherwood Swim Club Inc.
 19. No weapons allowed on property belonging to Sherwood Swim Club Inc.
 20. Please eat and drink in picnic areas.
 21. Inappropriate language, conduct, or public display of affection will not be permitted.
 22. Children must be accompanied by a parent or chaperone until they are 10 years of age and have demonstrated their ability to swim as determined by the lifeguard or pool board.
 23. Non-swimmers of any age must not enter deep areas.
 24. Persons taller than 48" may not use the junior pool. Children must be supervised by a responsible adult at all times as no lifeguard is assigned to this area.
 25. Members and Guests are responsible for cleaning up after themselves.
 26. All persons must stay clear of the lifeguard stands!
 27. No talking to lifeguard while on duty.
- Failure to abide by these rules will result in your expulsion from the pool area for the rest of the day.

Guest Rules

1. Only members and qualified guests will be permitted inside the pool enclosure.
 2. Each guest must be signed in and accompanied by a member.
 3. Sherwood Park residents who are not pool members will not be permitted as guests.
 4. Pool members are responsible for guest conduct.
- Guest fee: \$5.00 per person.

Diving Safety Rules

1. No diving from boards with floats, flippers, masks, tubes, goggles, balls, etc.
2. Only one person at a time on the diving board or ladder.
3. No loitering, sitting or hanging on the diving board or ladder.
4. No diving until everyone is clear of the diving areas.
5. One bounce only on the boards before diving.
6. Dive straight off the end of the board only.
7. Divers must swim to the nearest ladder immediately after diving.
8. Divers must exit out of the deep well immediately after diving.
